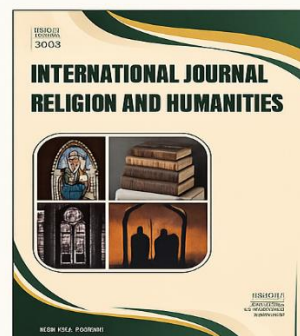

Leverage technology: NGOs can use online platforms to amplify voices, connect communities, and engage youth in meaningful exchanges.

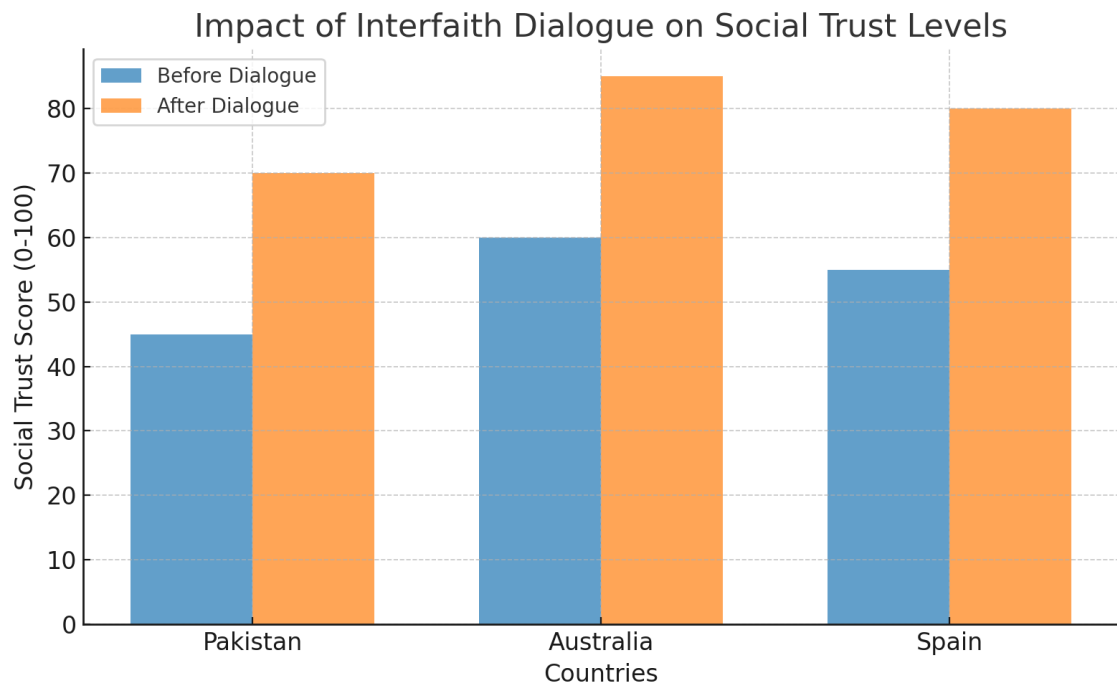
Religious Leaders and Institutions:
